LENDING CLOSET



Medical appliances are available on a **temporary basis** to Camden County senior residents 60+ years of age in need. Items include wheelchairs, canes, walkers, shower chairs, rollators, knee walkers and commodes. Adult diapers and bed pads are also available on a very limited basis (based on donations).

EMERGENCY FOOD

Non-perishable food items are available for low income Camden County residents 60+ years old, excluding Camden City residents. The program is based on income and the availability of resources.

Assistance is available once a month and provides four days of meals.

EMERGENCY RELIEF



This program provides one-time financial assistance to seniors 60+ years of age with home energy bills where service is in danger of being terminated or has been terminated due to non-payment, fuel, heater repairs and replacements and central air conditioning repairs and replacements as funding becomes available.

Eligibility is based on the household income and level of need.

This is not an entitlement; it is a case by case assistance available once per calendar year based on funding.

SHUT-IN SHOPPING



This bi-weekly shopping service is available to **homebound** seniors 60+ years of age based on the availability of volunteer shoppers. Clients are responsible for the cost of all purchases.

A screened volunteer will take a shopping list to the supermarket or pharmacy to purchase up to 20 items for the **client's use only**.

ENTITLEMENT AND PROGRAM COUNSELING

Assistance with entitlement applications is available to **program clients**.

Information is also available on living wills, Jersey Care, nutrition programs, support services, etc.
