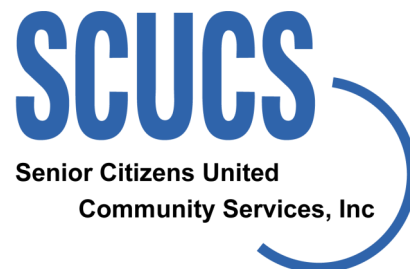

HOME ASSESSMENT



The initial assessment is done in the client's home and includes a complete physical and psycho-social evaluation. A financial review is conducted to determine the client's ability to pay for services and eligibility for County/State supported services. At this time, a Home Safety Evaluation is conducted. The information from these activities will determine the Care Plan that will be developed for each individual client.

BENEFITS/BUDGET COUNSELING



This service includes a total review of the client's current and future financial situation.

From this information, a budget will be formulated to ensure the client's needs can be met financially.

CARE/PLAN



After the home assessment, a Care Plan will be developed by the Care Manager. This will include recommendations and referrals to entitlement programs, community services and risk assessment.

PLAN IMPLEMENTATION/COUNSELING



You can choose to have the SCUCS Care Manager implement the Care Plan for you. This would include completing applications, contacting community resource programs and coordinating professional services.

The Care Manager would contact providers to schedule needed services and perform follow-up for each activity. The Care Manager would act as the Client Advocate in implementing the Care Plan.

MONTHLY CASE MANAGEMENT



The Care Manager would conduct monthly client visits as needed, as well as maintain phone contact with clients, caregivers, providers and entitlement programs.

As a monthly client, the Care Manager will oversee and manage all existing services, as well as monitor the client's need for additional services as their needs change.
