Mount Laurel Township has an agreement with Senior Citizens United Community Services, Inc (SCUCS) and their program, SEN-HAN Transit, to provide an additional Wednesday shopping service exclusively for Mount Laurel residents in addition to those funded through the Casino Revenue Funds. Rides are provided on a first-come, first-served basis.

SEN-HAN operates a **reservation only** system for all demand services. First time passengers must call **(877) 603-5111** to pre-register for service. <u>If you have been using SEN-HAN Transit, you will not need to complete the phone intake process</u>.

Call to reserve your ride each week or you will not be picked up. Please call **(856) 255-5348** between the hours of 6:00 am and 5:00 pm the working day before your trip. Follow the instructions to leave a message for the shopping program. Speak slowly and clearly. Give your name, address with city, phone number and the Zone number and letter of your route (see above). For example, if you live in the Renaissance Club, you would call in on Monday for Tuesday and Wednesday for Thursday between 6:00 am and 5:00 pm, state your name, address with city, phone number and give your zone as Zone ML-1. Remember to limit purchases to **four normal grocery store bags** unless you are able to carry all of the purchases yourself by using a soft-sided folding grocery cart.







There is <u>NO</u> tipping of the driver permitted. Available in alternate format upon request

This is a door-to-door service.

All passengers are required to use seat belts. All passengers using transport devices must use shoulder and lap belts. Driver will secure all mobility devices using the vehicle's tiedown system.
